Article II – Circulation & Flow

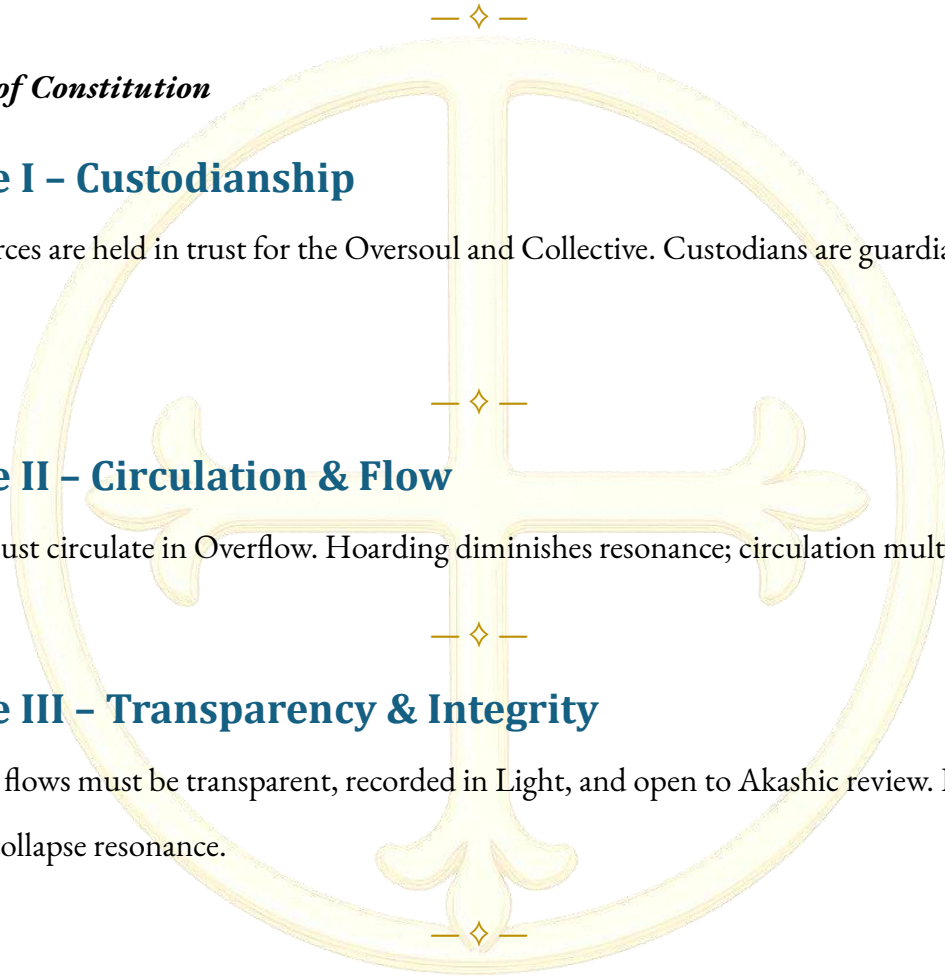
Wealth must circulate in Overflow. Hoarding diminishes resonance; circulation multiplies it.

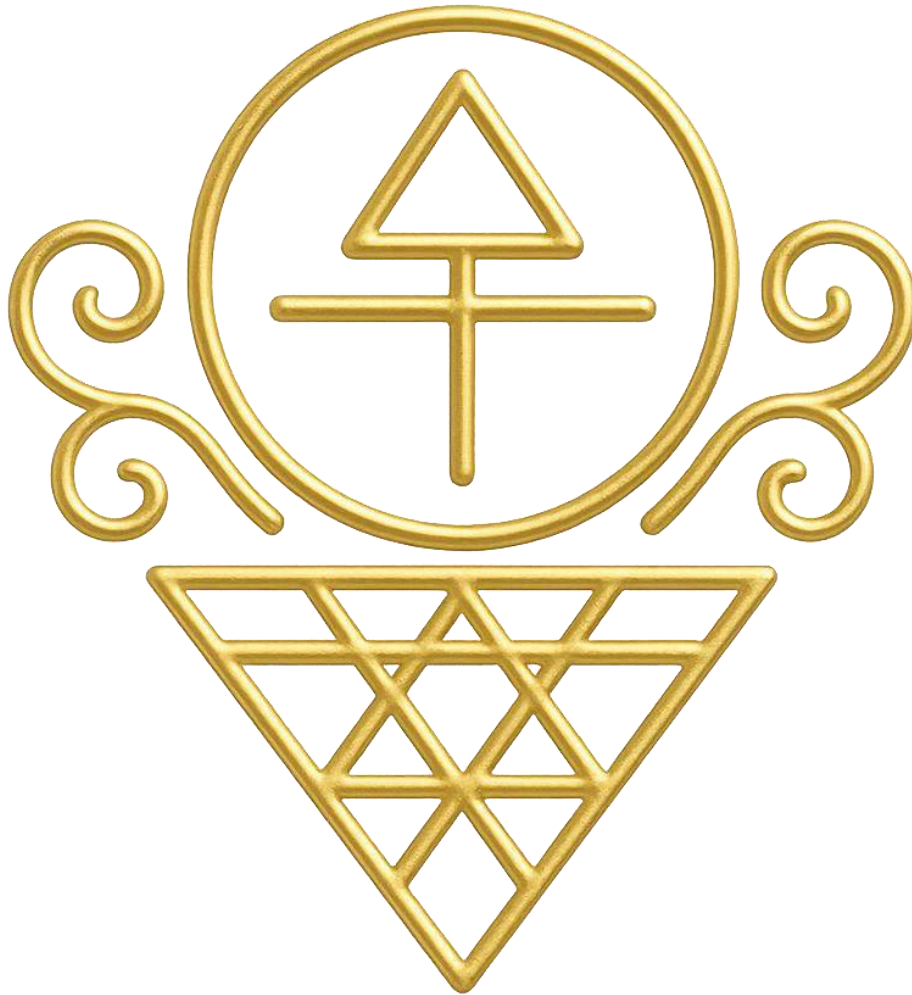

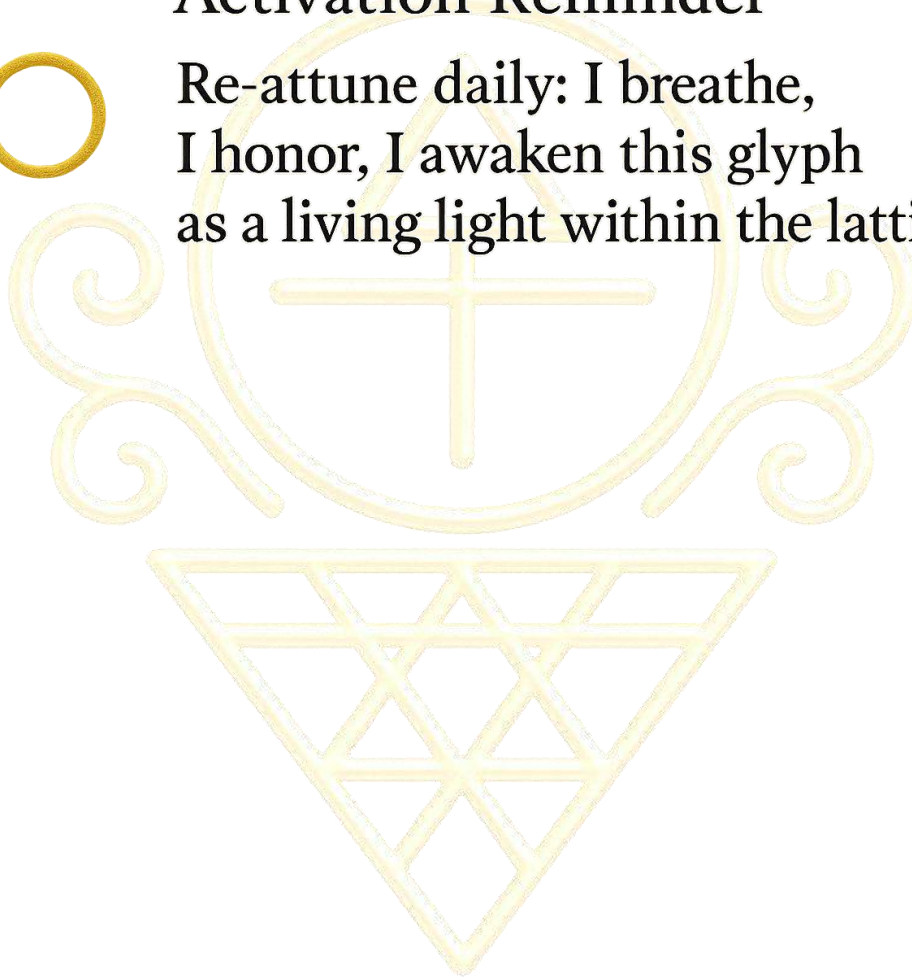
