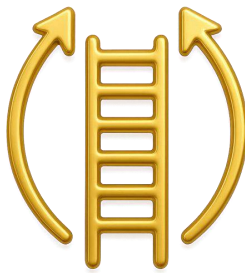

- **Physical:** Instability, heaviness, lack of provision.

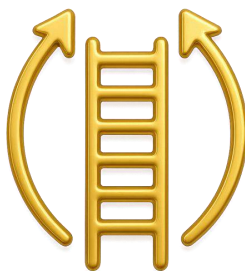
Build & Stabilize

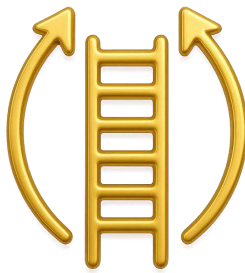
- Use this ladder to **discern your current band** — not as judgment, but as orientation.
